Valid for equipment purchased and installed on or after November 28, 2008, with the following exceptions:

- Water heaters listed must be purchased and installed on or after February 26, 2011.
- Programmable setback thermostats purchased and installed prior to February 26, 2011 must be ENERGY STAR® qualified. Programmable setback thermostats purchased and installed on or after February 26, 2011 qualify if they feature four (4) pre-programmed settings for 7 day, 5+2, or 5-1-1 day programming capability.

All applications must be **postmarked within ninety (90) days of the date your reservation code is issued**. Eligible equipment must be installed in a home with an active Laclede Gas or Missouri Natural Gas account. Furnace, boiler, or water heater rebate applications that are submitted without an active reservation code may not be approved if unreserved funds are not available. Programmable setback thermostat rebate applications may not be approved if unreserved funds are not available.

Rebate Limit: Individual dwelling units, as determined by account number, whether owner-occupied or rental property, are eligible for a maximum of two heating system rebates, two programmable setback thermostat rebates, and one water heater rebate under this program. Owners of multiple individually metered dwelling units are limited to a maximum of 50 heating system rebates, 50 programmable setback thermostat rebates, and 50 water heater rebates during one program year.

This rebate is available to all residential customers of Laclede Gas Company and its operating divisions (Laclede). It is subject to the terms and conditions of the program and to change or terminate without prior notice. Funding is limited. Funding is administered by EFI and provided to Laclede customers in cooperation with the Missouri Public Service Commission, the Office of the Public Counsel, and the Missouri Department of Natural Resources. Laclede reserves the right to conduct field inspections to verify installations. Laclede does not guarantee the performance of installed equipment expressly or implicitly.
